Executive Summary

The Ministry is undertaking website modernization through the development of a new website to replace its existing one. This document provides an overview of the current status of the Ministry of Sport and Youth Affairs (MSYA) website upgrade project. It summarizes progress to date and highlights outstanding issues related to website structure and content that remain from the previous development process, which lacked appropriate technical consultation.

The report is organized into two sections. **Section 1** outlines the progress of the current development effort, which aims to correct earlier deficiencies. **Section 2** identifies still missing or insufficient website content. The website modernization effort also seeks to align with Trinidad and Tobago's National ICT Policy and e-Government Strategy.

Section 1: Progress of the current development effort.

Website Infrastructure:

- I. The WordPress website reachable via URL: <https://www.mydns.sycadi.org/> was migrated from a third party hosting provider to MSYA's On-premises servers, accessible at URL: <https://webcomms.msya.gov.tt>.

- II. Additional back-end services that aid the development process, were also configured (W3C Web Accessibility Initiative (WAI), 2023).
- III. A thorough evaluation of the website was conducted.
- IV. The re-factoring of the website's content management structure to implement Custom Posts Types and Taxonomies is in progress (Beck et al., 2021).

Section 2: Representation Deficiencies (*Missing or insufficient website content*)

The previous development process contains deficiencies in the following areas:

1. **Functional Gaps:** Potential failure to address features required by all of the ministry's departments/ units and entities.
2. **Content Management:** Lack of content/ input from all of the ministry's departments and entities across the organization, that are to be represented on the website.

Conclusion

Section 1 - The current development effort:

The re-factoring of the “new” website presents that following challenges given the stated time constraint:

- The internal structure of the websites consists of disjointed static text/ contents that is proving to be problematic to renovate, given the limited time.
- Serious consideration is being given to completely re-do/ build the website from the ground up, according to industry best-practices (Kim et al., 2020) and the standing government's ICT policies.

Section 2 - Still missing or insufficient website content.

Missing or insufficient website content is needed in a timely manner as it directly affects the website's development and project delivery. Therefore, In order for the mandated deadline

for the website's deployment to be realised, all requisite content must be properly vetted and authorized for publishing. This said **content must be provide at least 2 weeks prior to the launch of the websites**. The proposed approach provides a framework for developing a secure, high-quality, and maintainable website that properly serves the needs of all stakeholders while ensuring compliance with legal requirements (Trinidad and Tobago, 2019), data protection standards (Stamos, 2022), and industry best practices (OWASP Foundation, 2023).
